URGENT: The situation requires your intervention

Presidency of the Council of the European Union

We contact you given the serious situation that we Spaniards are living, worsened by the actions of the European Union, with the added danger of the upcoming Spanish Presidency of the Council of the European Union.

On 11.11.2022, from the alliance Denunciators of Judicial Authoritarianism we denounced the governments of Sanchez (2018-2022) in the European Commission, being processed in Unit F.3 of the Directorate general for Economic and Financial Affairs of the European Commission, as Ares(2022)8174536.

On 27.01.2023, the Alliance submitted an extension of the complaint being processed in Unit C.1: Justice Policy and Rule of Law of Directorate General C: Fundamental Rights and Rule of Law, registered as Ares(2023)1525948.

In these two complaints, it is accredited that the governments presided by Pedro Sánchez have usurped the functions of the Parliament, reaching what is known as a legal coup d'état with the declaration of the state of alarm. He has repeatedly falsified the official documentation sent to the Spanish Parliament and to the European Commission, with the aim of making the public sector grow as much as possible, following in the footsteps of Hugo Chávez in Venezuela.

The European Union has made a mistake by allowing and financing it, especially after receiving our complaints.

In the first semester of 2022, we denounced several European politicians and judges appointed by the Spanish Government for money laundering. In the case of José Borrel, for having been bribed. We provided the identification of the bank deposits where he received the bribe, which is described in written documentation. The bribe was made by José Luis Rodríguez Zapatero (President of Spain 2004-2011), on behalf of a group of U.S. financiers.

The complaints for money laundering were filed by Ville ITÄLÄ, Director General of OLAF, alleging that OLAF could decide at its discretion which complaints to investigate; however, our complaints already provided the investigation and it was only necessary to check if the information was true. Moreover, it is incomprehensible that

there being a serious security risk in the European Union, it is not checked.

On 16.12.2022, we have denounced 60 million euros collected from Qatar by the first six involved and twelve advisors of Spanish MEPs who received one million each from Qatar. We have also provided all the banking information, but we have not received a reply from the European Commission or OLAF.

We have denounced other very serious facts that have not yet been processed.

We are concerned about the totalitarian drift of Spain and the European Union, in a context of decadence that is being accelerated by the Coronavirus Crisis, especially by the responses of the European governments and the European Union itself.

The NextGenerationEU Recovery Plan is a disaster due to the enormous corruption, contrasted with the huge public debt, of countries such as France, Italy, Spain, Belgium, Portugal, Greece and others. The lack of rigorous Rule of Law Reporting in these countries to give away and lend huge amounts of money is serving to increase corruption and accelerate decay, weakening the European Union vis-à-vis the United States and China.

We trust that the EU Council will intervene so that the next Rule of Law Reports of the member countries will be rigorous and serve to prevent the financing of corruption, decadence and, probably, the disappearance of the Euro and the collapse of the European Union.

The European Union must suspend the Presidency of Spain in the Council of the European Union until the Spanish institutions ensure compliance with the law. In this sense, we suggest that the Belgian Presidency be brought forward, and that the Swedish Presidency be extended for a few months until Belgium is ready.
