MESSAGE TO THE EUROPEAN PARLIAMENT FOR CRIMINAL COMPLAINT AGAINST THE SPANISH GOVERNMENT

We are forwarding the e-mail we have sent to members of several economics committees of the European Parliament, hoping that they will find it convenient to inform their readers:

SUBJECT: Complaint against Spanish Government for economic disaster

Dear Members of the European Parliament,

We share the concern about the decadent totalitarian drift of the Spanish Government, taking advantage of the lack of rule of law and other well-known international events.

We also share the view that the European Commission, with its unconditional support for corruption and non-compliance with the obligations of governments, has been jeopardizing the survival of the euro and the European Union for years. The Commission's priorities are to increase its power and its budget, with the terrible consequence of accelerating European decline. We are grateful that the European Parliament has begun to demand that the European Commission start to assume its responsibility.

In this context, a group of five associations have denounced the current Spanish Government for its actions since 2018. We denounce the commission of a continuous crime of prevarication, embezzlement, false documentation and other crimes, which have harmed the financial interests of the EU (including the value of the euro) and those of its members.

The complaint has been forwarded on 11.11.2022 to the Supreme Court, requesting that it be transferred to the European Public Prosecutor's Office, which is the only competent body to investigate the facts, together with us as a popular accusation.

The complaint requests the Supreme Court to offer European governments the possibility of appearing in the case to defend their own interests and those of the European Union; in addition, we have informed several European Union governments, through their embassies in Spain, of this possibility.

We have translated the complaint into English so that they may know its ends, because surely they do not know the legal and economic falsehoods with which the Government has deceived the Spanish Parliament and the European Commission, with the intention of obtaining the result that you know: the economic ruin of Spain for decades and putting at risk the existence of the Euro and the European Union.

The complaint has been simultaneously forwarded to the European Commission, so that it can properly assess the actions of the governments of Pedro Sánchez (2018-present) and verify that the Government has a total disregard for legality and for its own commitments to the electorate and to the European Union.

We trust that the information contained in the complaint will serve you to understand well the dangerous situation and, in that way, you will be able to avoid that the same thing continues to be done by this Government and by future governments led by the PSOE or by the PP. You (members of the Europarliament) have been elected by the Europeans, unlike the leaders of the European Commission and its agencies that have been elected by the corrupt governments, so the Parliament must impose itself, as it is done in the member countries.

We will publish on our website the progress of our complaint so that you, GRECO, the press and others can be informed.
